OUR VISION IS TO DEVELOP CITIZEN-ATHLETES WHO TAKE AN ACTIVE ROLE IN THEIR SOCIETY'S TRANSITION FROM WAR TO PEACE. SINCE 2015, ASCEND HAS PUT OVER 100 YOUNG WOMEN THROUGH A 2-YEAR TRAINING PROGRAM THAT PREPARES GIRLS TO BE PHYSICALLY AND MENTALLY STRONG AND ENCOURAGES THEM TO BE ACTIVE COMMUNITY LEADERS AND ROLE MODELS.
