Leadership Development

Ascend provides holistic training and development for each program participant, with the goal of strengthening the whole person in order to empower her to drive positive change. Activities included tailored leadership classes and one-on-one instructor development; group therapy sessions to build bonds between participants and encourage emotional growth; and rotating leadership of physical activities such as weekly hikes and fitness workouts.

Mountain Climbing

In 2018, Ascend trained 22 Afghan girls, ages 15-24, in mountaineering hiking, and rock climbing. We took five major trips to the Afghan mountains, including a month-long expedition to Mt. Nushaq, Afghanistan's highest peak (24,580'). Every program participant received training in physical fitness, yoga, nutrition, and health, and technical climbing skills. For the majority of participants, our week-long mountain trips were their first time spending the night away from home. Through our expeditions, the girls visited the provinces of Bamyan, Panjshir, and Badakshan.

Civic Engagement

Program participants engage with their communities primarily through public speaking and volunteer projects. Each program participant designed and implemented a project of her choosing that would serve her community, such as teaching art to internally displaced children, organizing neighborhood clean-ups, and providing fitness classes to vulnerable women.

Through public speaking our participants shared their message of female achievement and Afghan unity with thousands of people in Afghanistan and around the world. They spoke with major media outlets including
